**CHILI:** Please prepare plenty of chili – we expect 1000+ people.  
**8 quarts is the minimum** – but we would/could use much, much more!

### SUPPLIES & EQUIPMENT:

Contestants provide their own crockpot, heating plate, camp stove or other cooking/ heating device. Electricity will be available about 20 feet away – bring your own extension cord if necessary. Contestants bring their own condiments. The organizers will provide an 8' folding table chairs, tasting cups, spoons, etc. You may arrive anytime during the day to set-up and prepare your chili. **Chili and booth should be ready for tasting and judging by 5:00 p.m.** Gates will open at 5:00 p.m.
